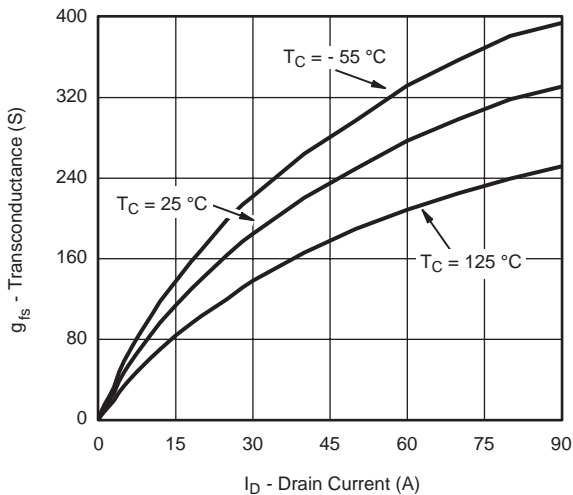

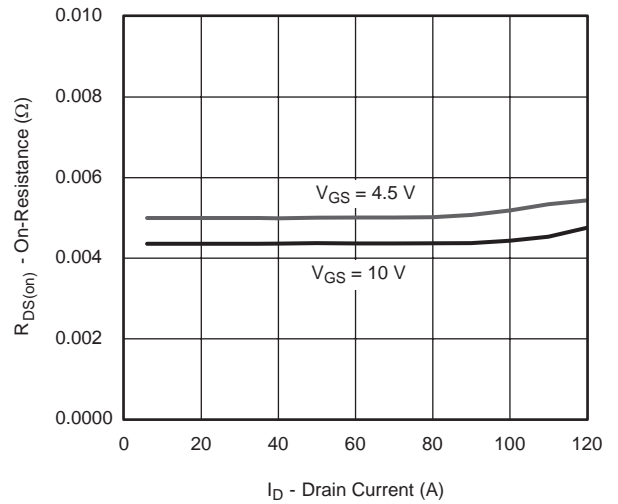

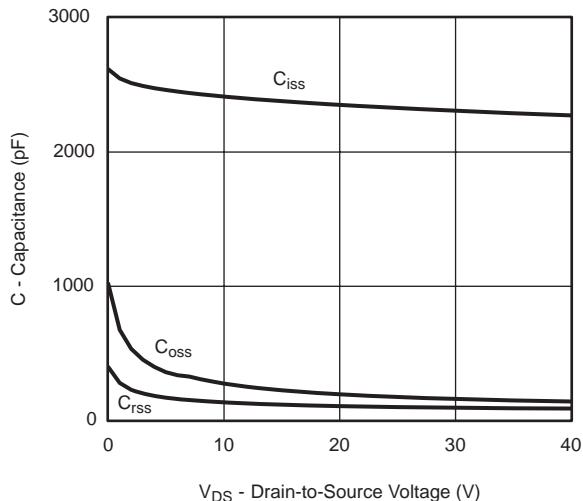

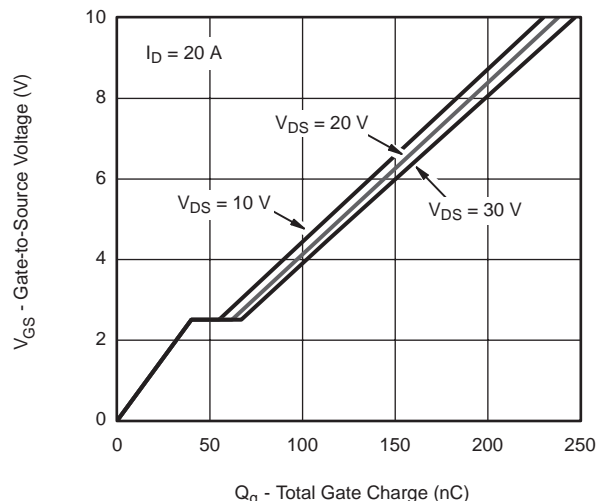
Transconductance

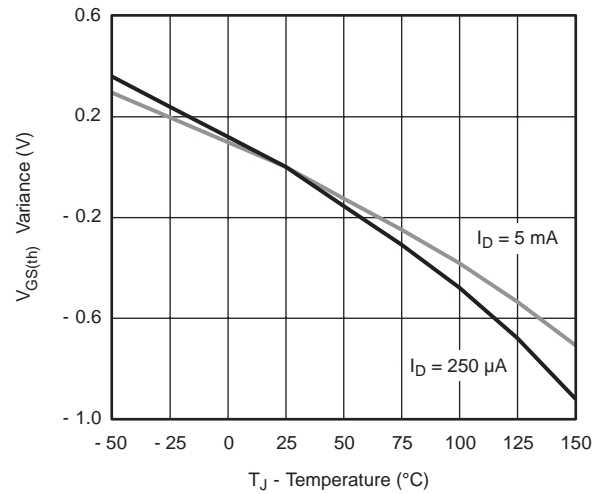
On-Resistance vs. Junction Temperature

Threshold Voltage



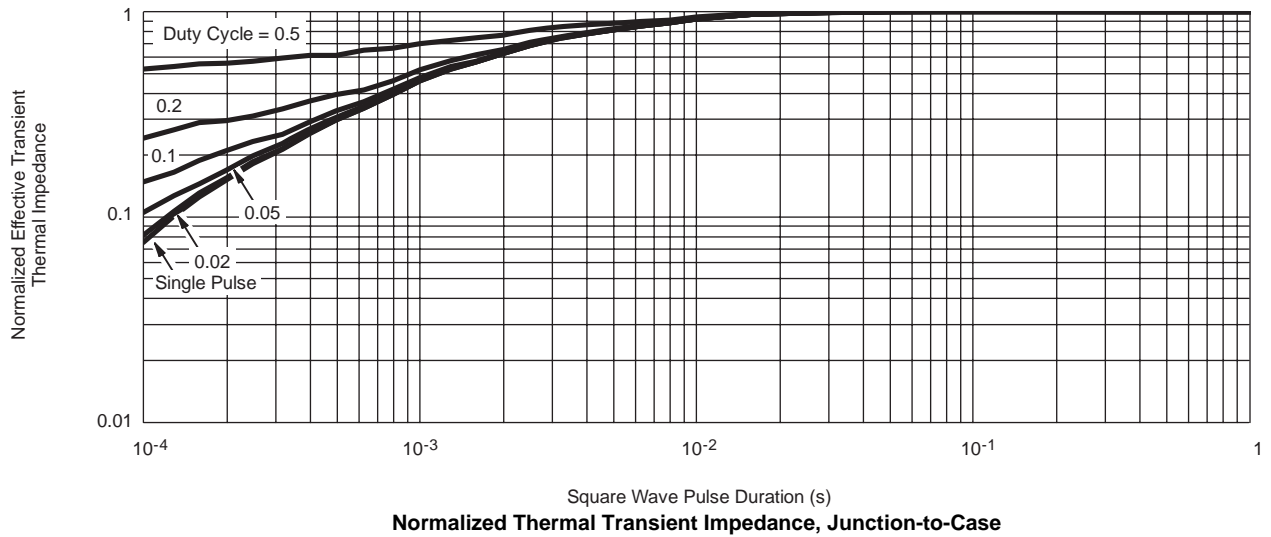

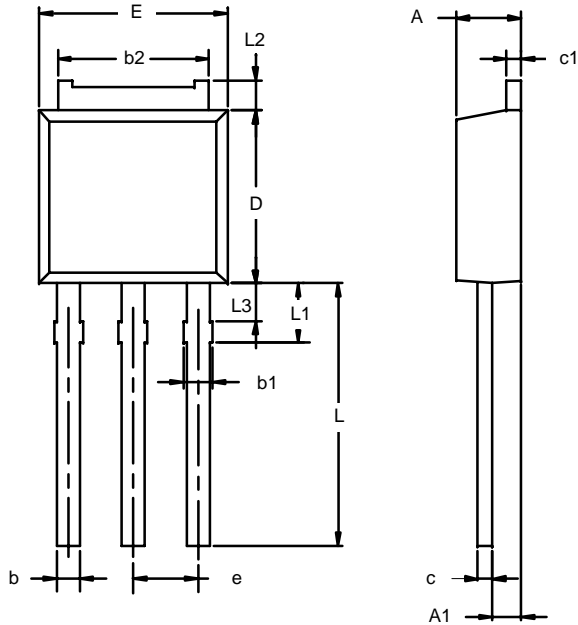
