




#### Transconductance






R<sub>DS(on)</sub> vs. Drain Current






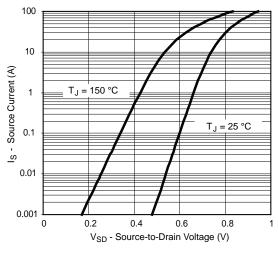

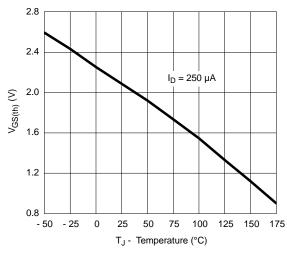
On-Resistance vs. Junction Temperature




 $\rm R_{\rm DS(on)}$  vs.  $\rm V_{\rm GS}$  vs. Temperature



Forward Diode Voltage vs. Temperature








Safe Operating Area, Junction-to-Ambient







Normalized Thermal Transient Impedance, Junction-to-Case




DFN5x6\_8L\_EP1\_P PACKAGE OUTLIN










<u>VIEW 'A'</u> (SCALE 5:1)
