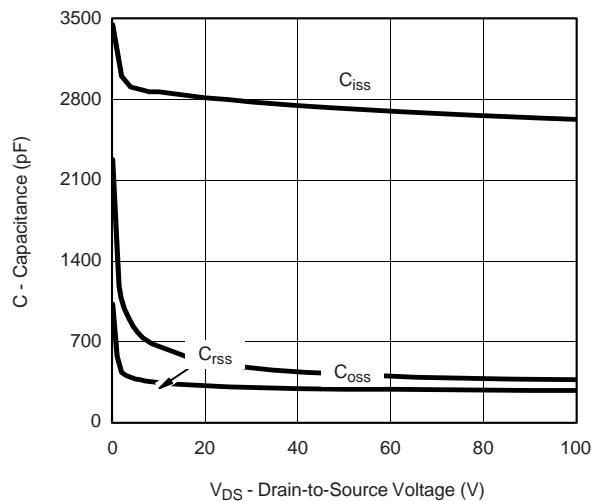

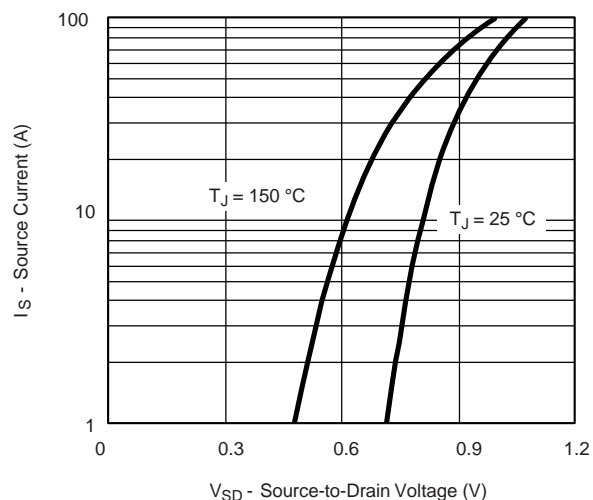

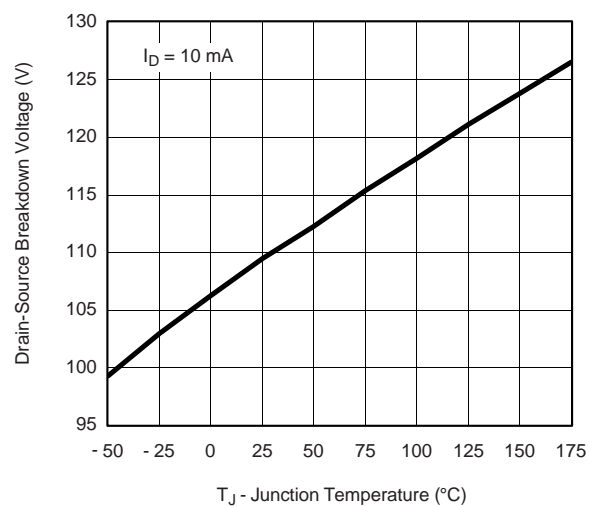

Maximum Avalanche and Drain Current vs. Case Temperature



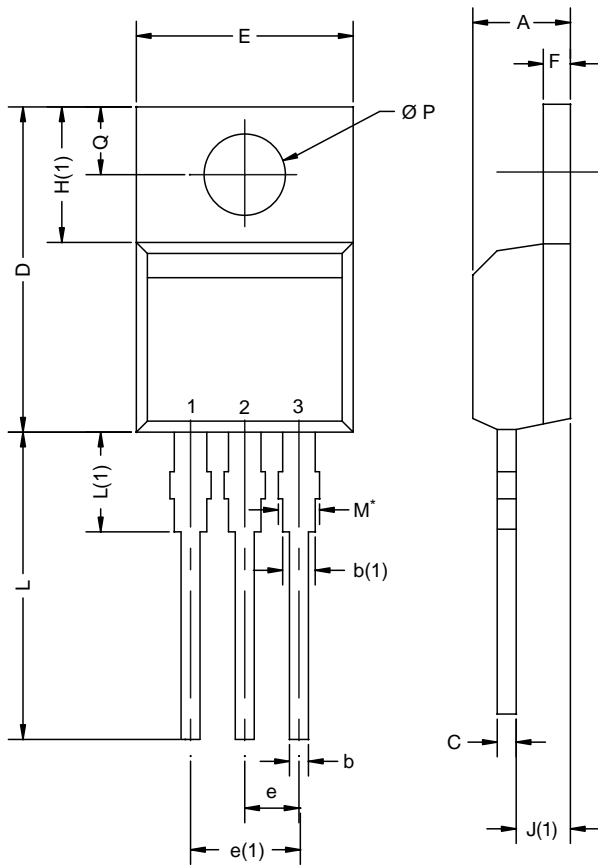
