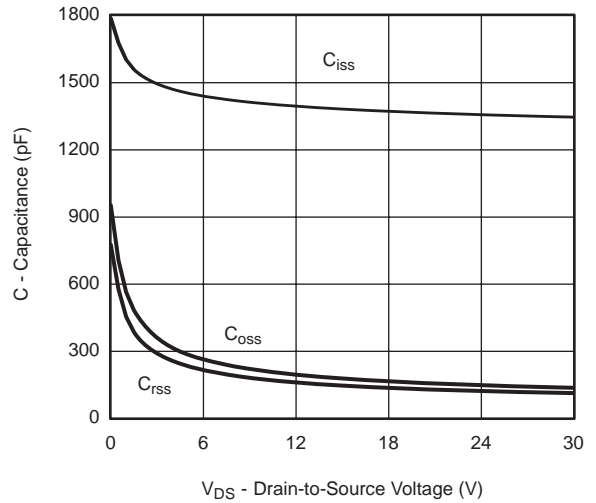

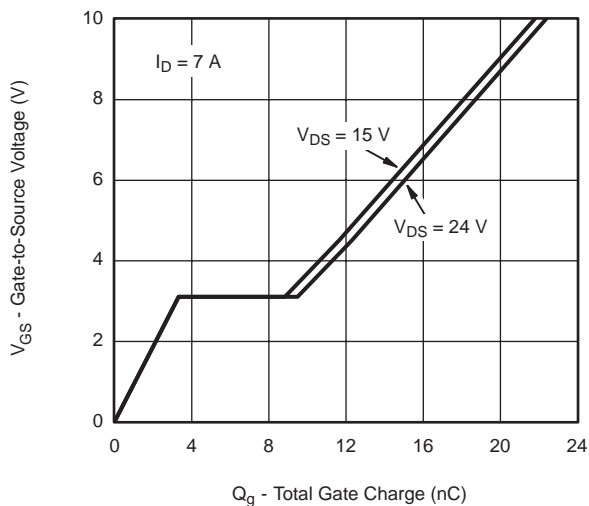

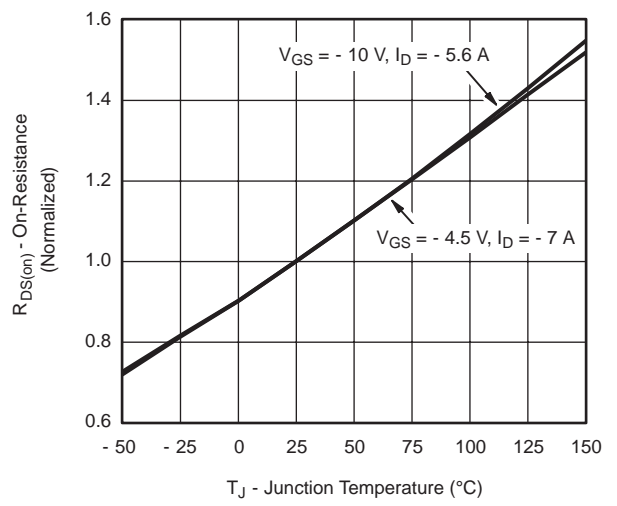
On-Resistance vs. Drain Current



Capacitance

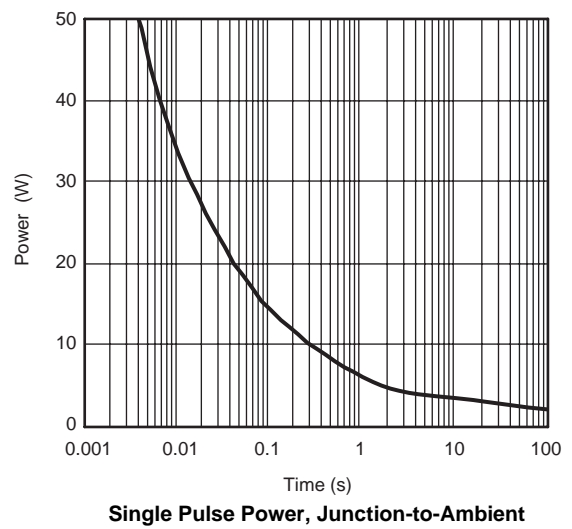
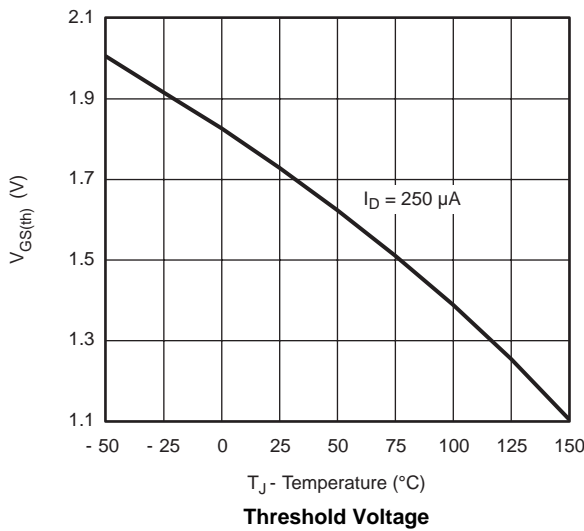
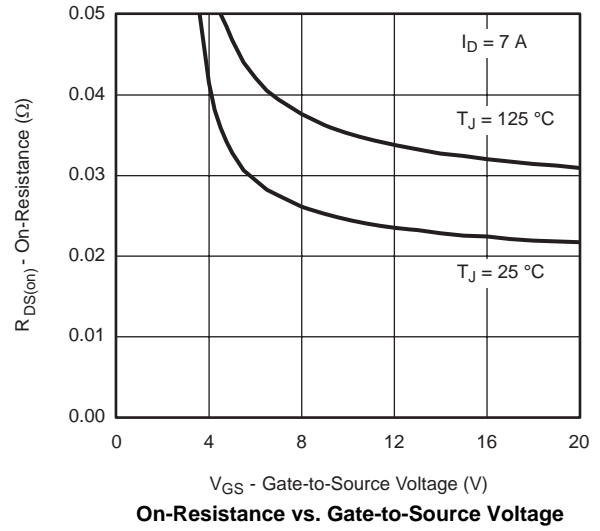


Gate Charge

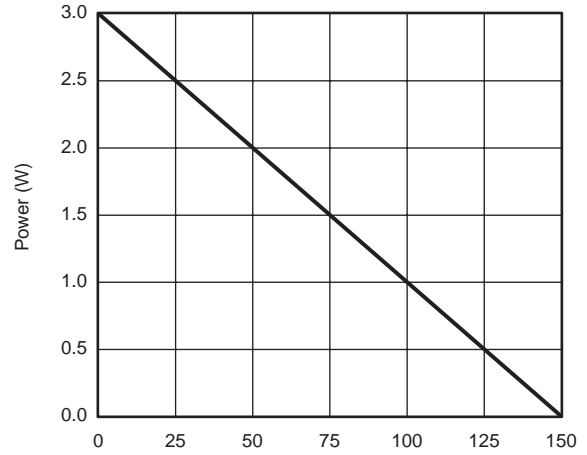

Power, Junction-to-Foot



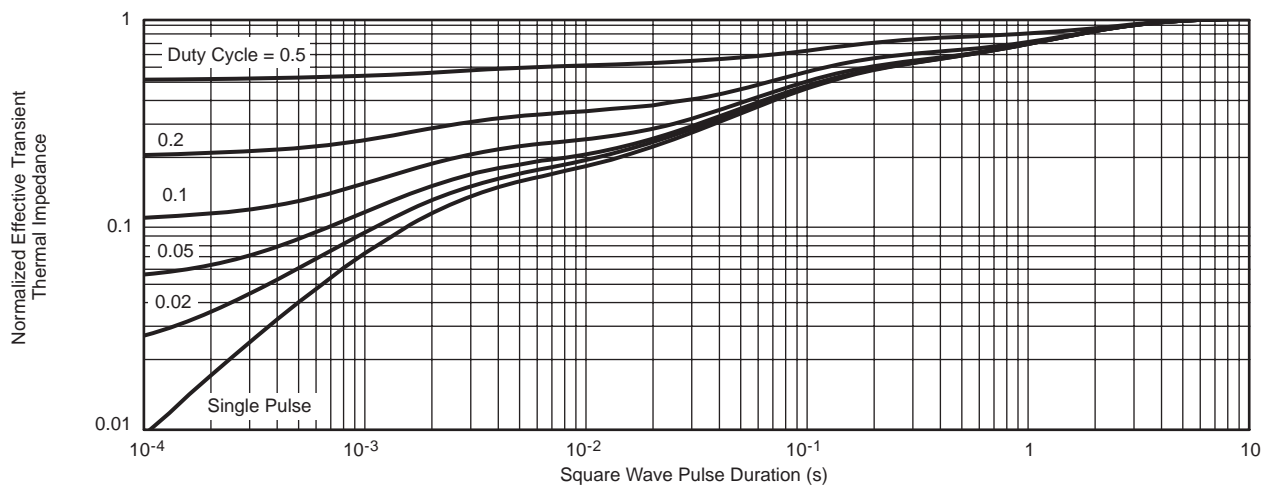

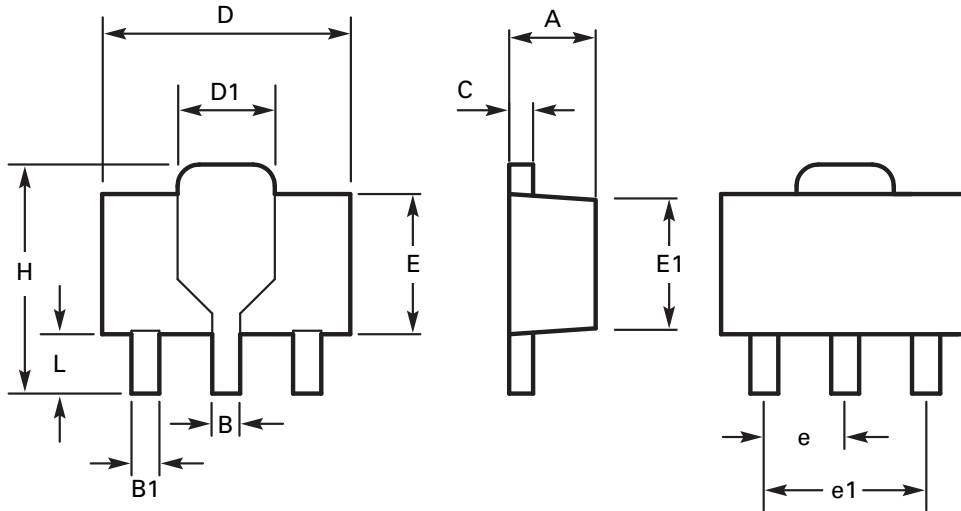


Normalized Thermal Transient Impedance, Junction-to-Ambient
