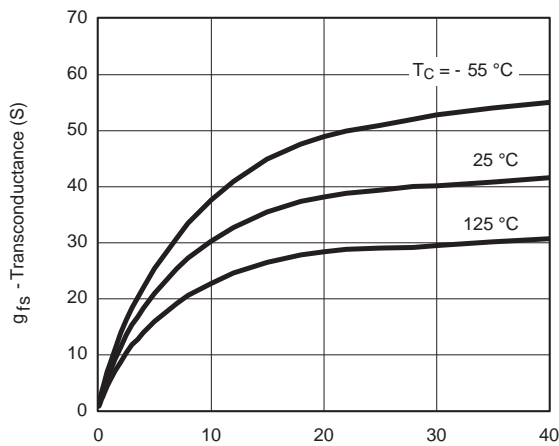

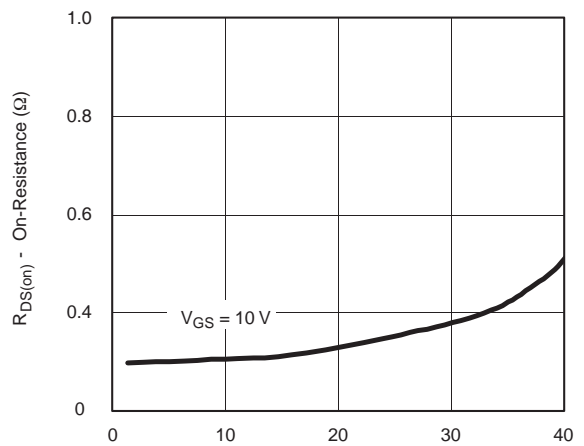

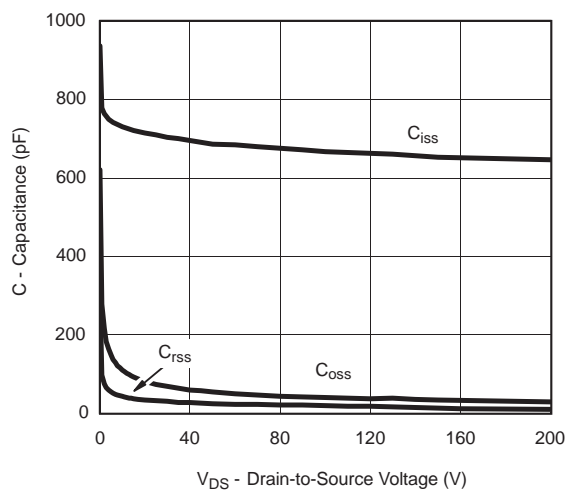
Transfer Characteristics



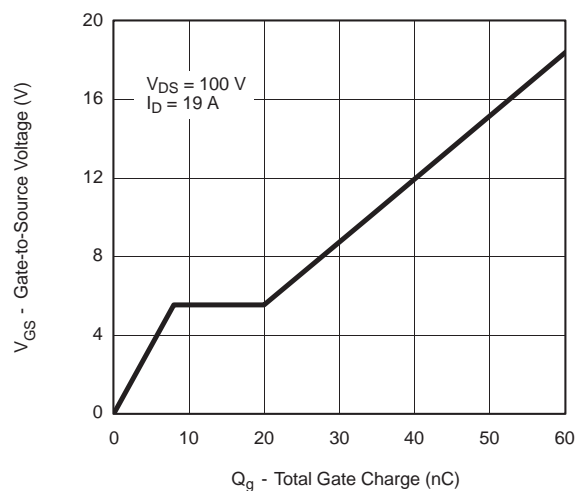
Transconductance



On-Resistance vs. Drain Current

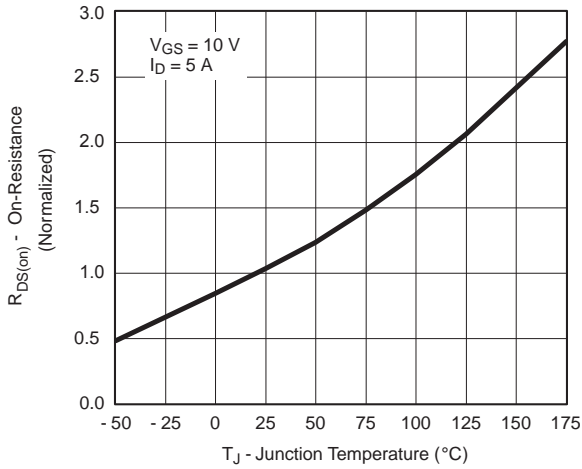


Capacitance

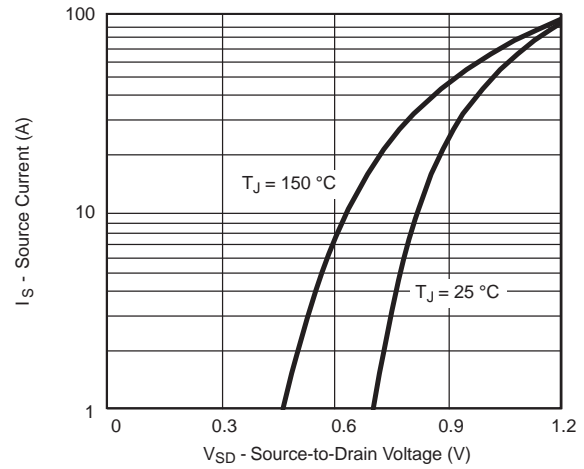


Gate Charge

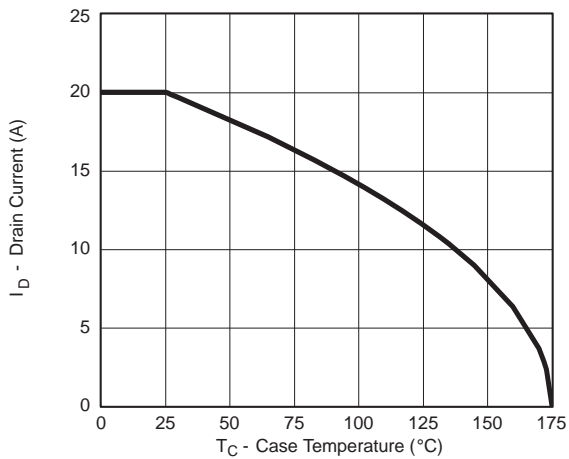


On-Resistance vs. Junction Temperature

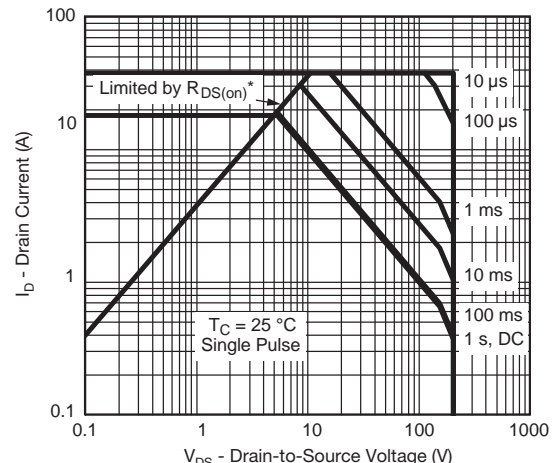


Source-Drain Diode Forward Voltage

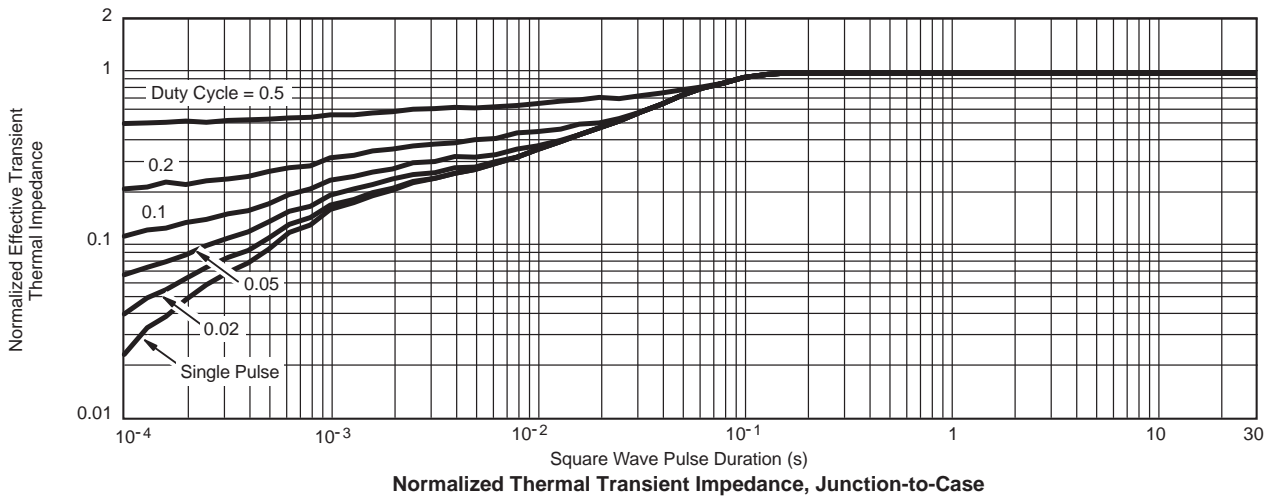

Maximum Avalanche Drain Current vs. Case Temperature

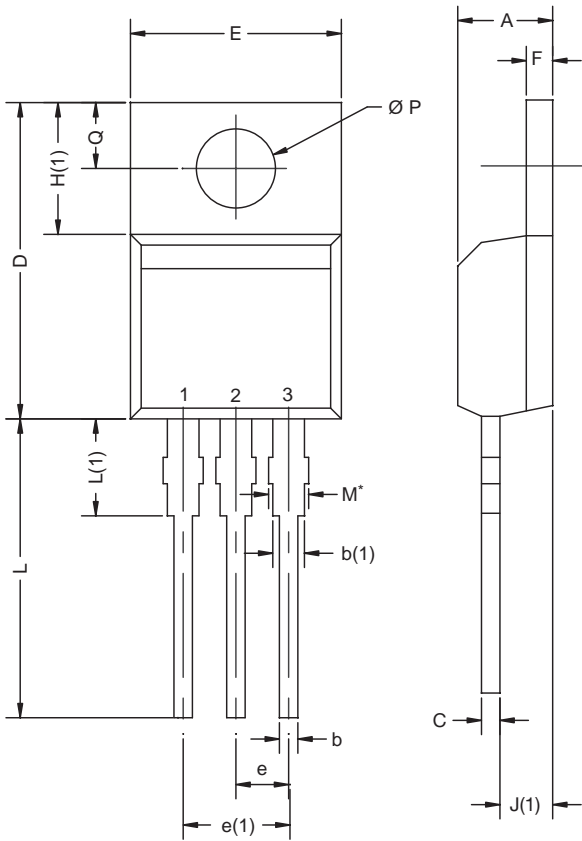
