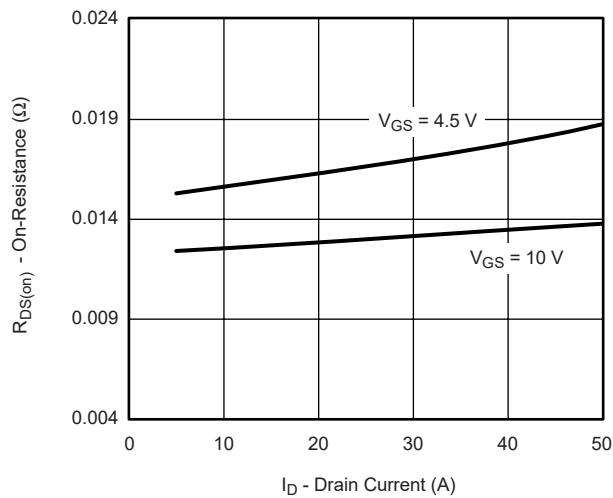

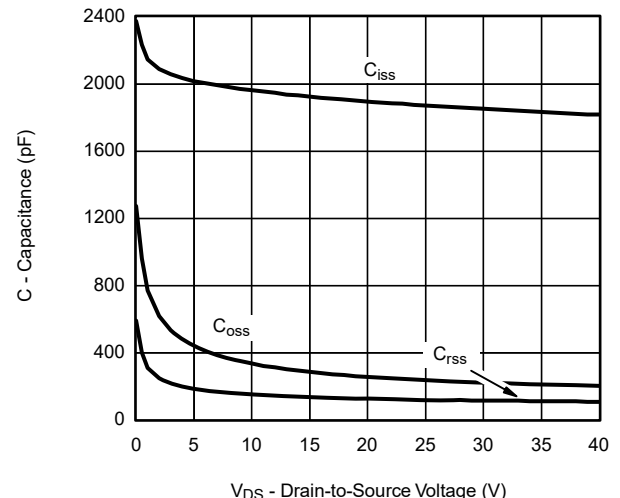

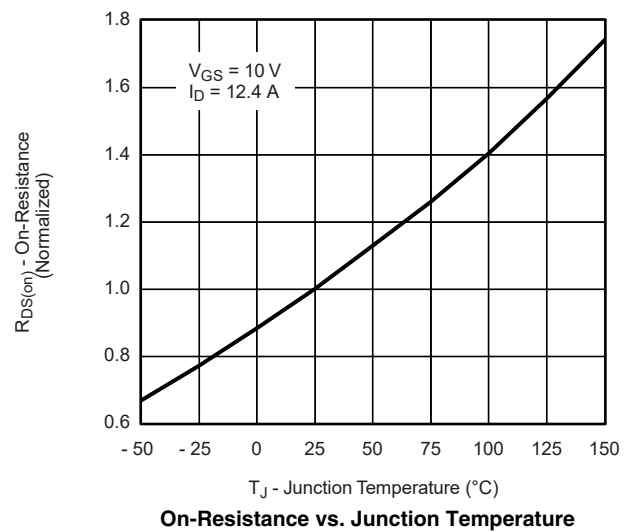
**Transfer Characteristics**



**On-Resistance vs. Drain Current and Gate Voltage**



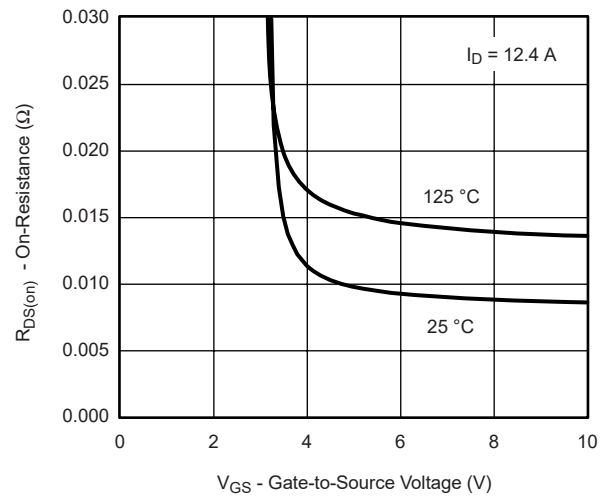

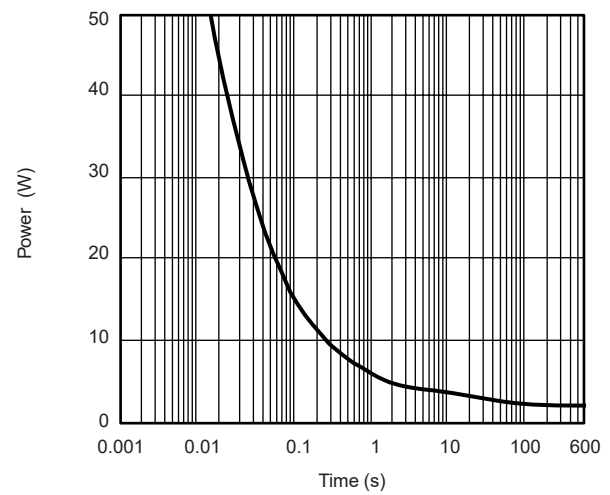
Source-Drain Diode Forward Voltage

Threshold Voltage



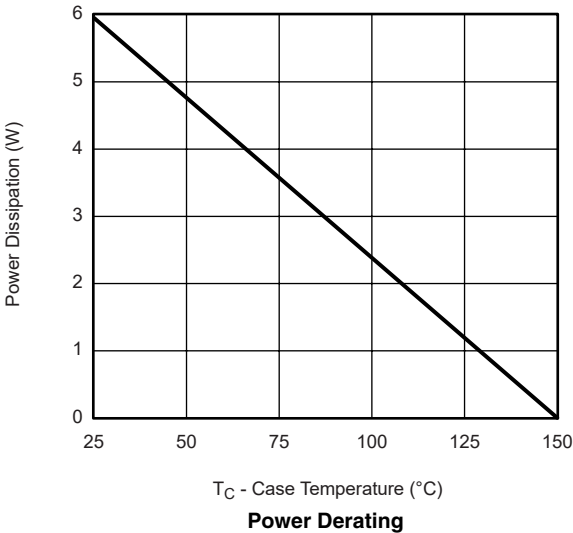
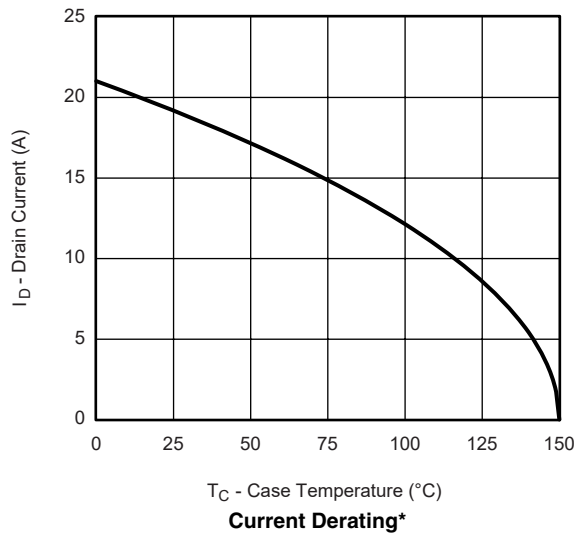

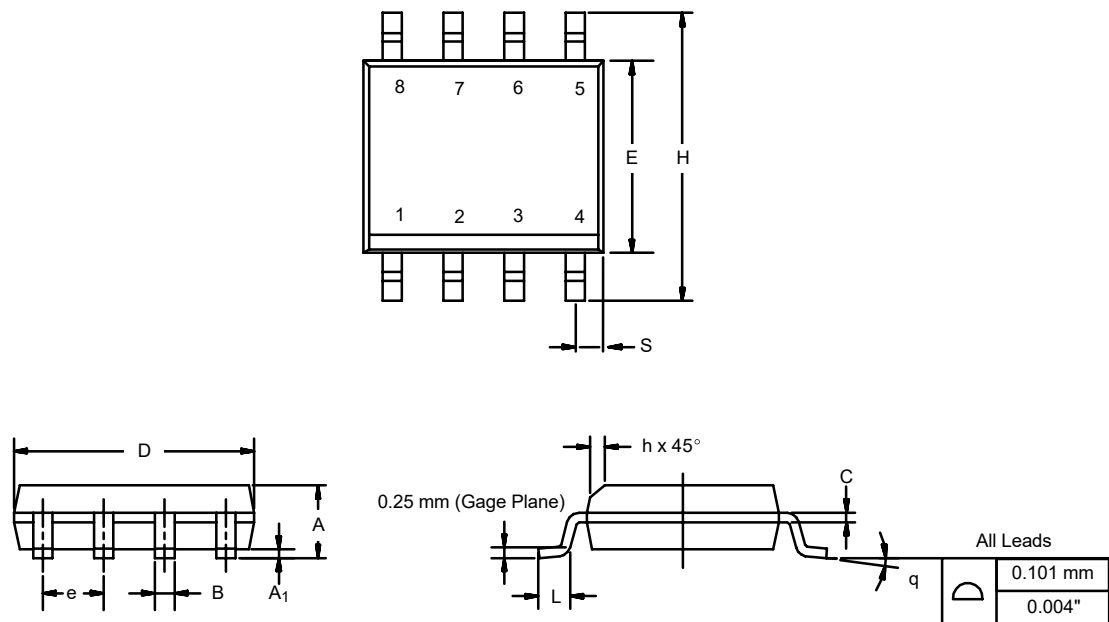
