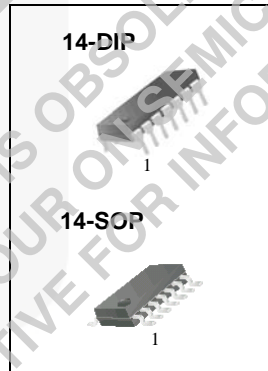

Block Diagram

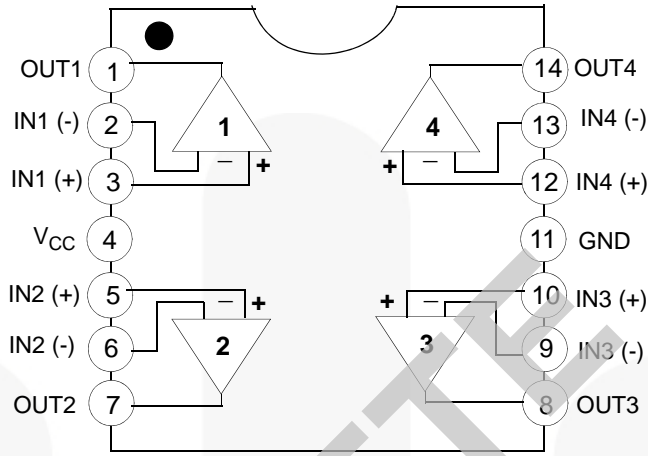


Figure 1. Block Diagram

(One Section Only)

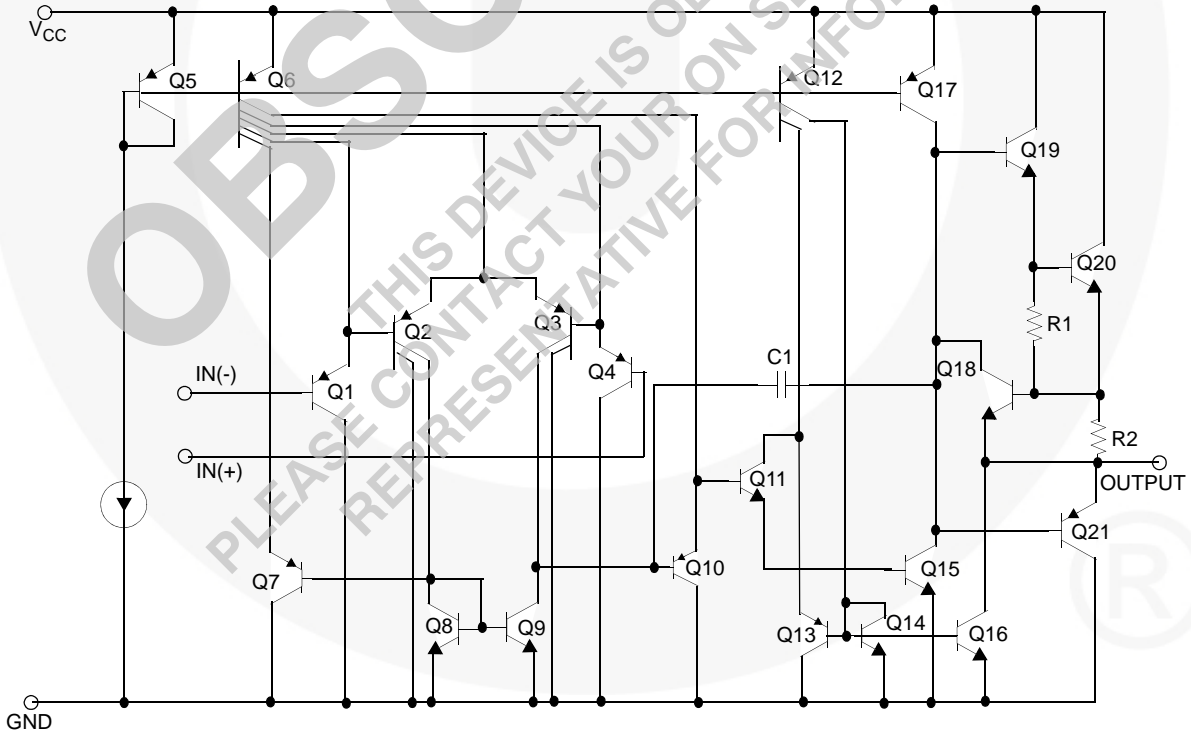


Figure 2. Schematic Diagram

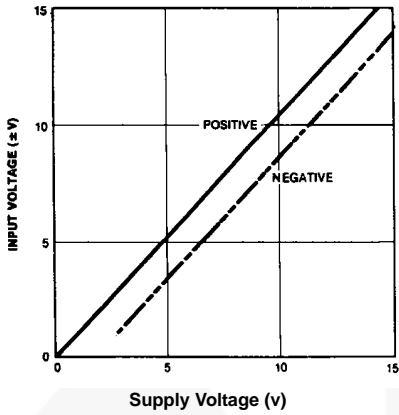


Figure 3. Input Voltage Range vs. Supply Voltage

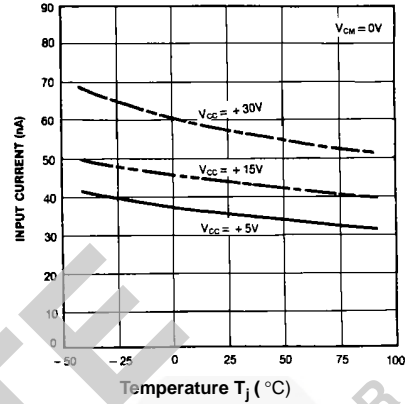


Figure 4. Input Current vs. Temperature

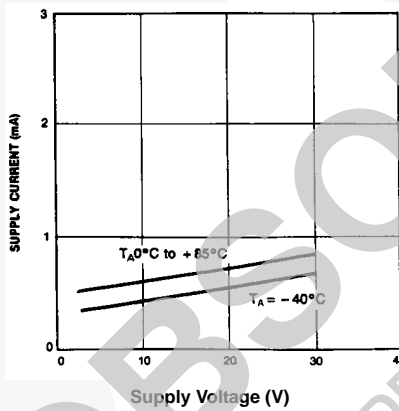


Figure 5. Supply Current vs. Supply Voltage

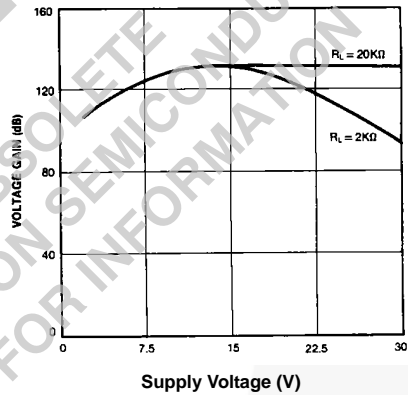


Figure 6. Voltage Gain vs. Supply Voltage

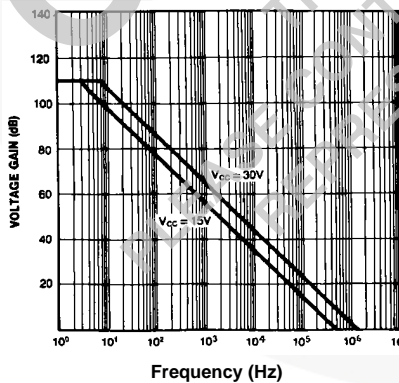


Figure 7. Open Loop Frequency Response

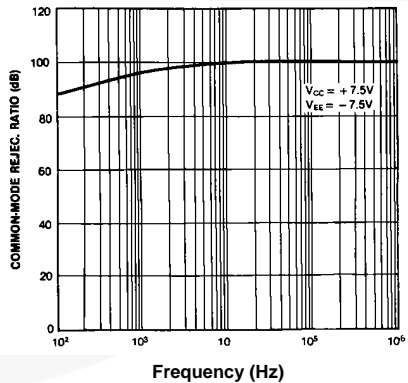


Figure 8. Common Mode Rejection Ratio

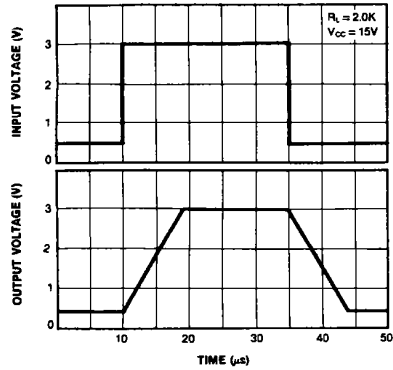


Figure 9. Voltage Follower Pulse Response

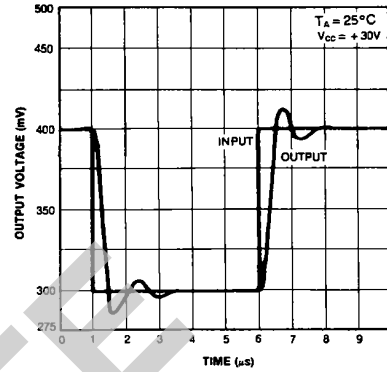


Figure 10. Voltage Follower Pulse Response (Small Signal)

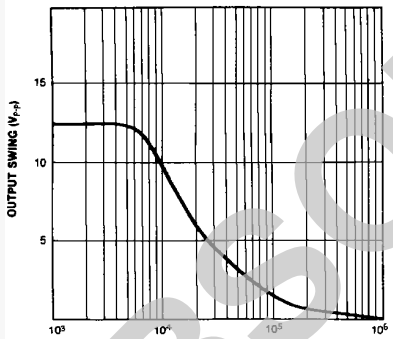


Figure 11. Large Signal Frequency Response

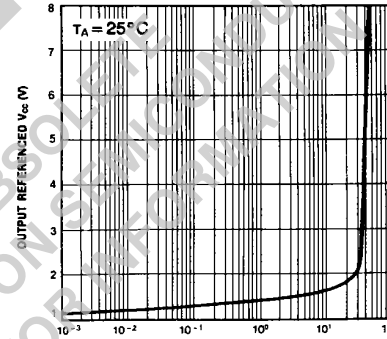


Figure 12. Output Characteristics vs. Current Sourcing

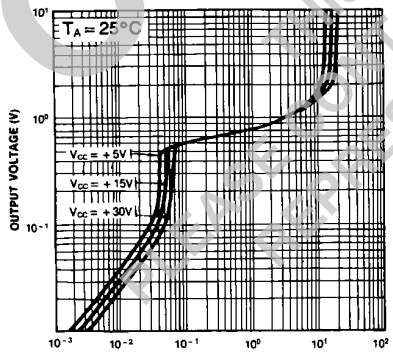


Figure 13. Output Characteristics vs. Current Sinking

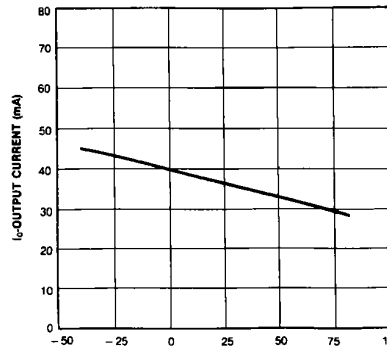


Figure 14. Current Limiting vs. Temperature

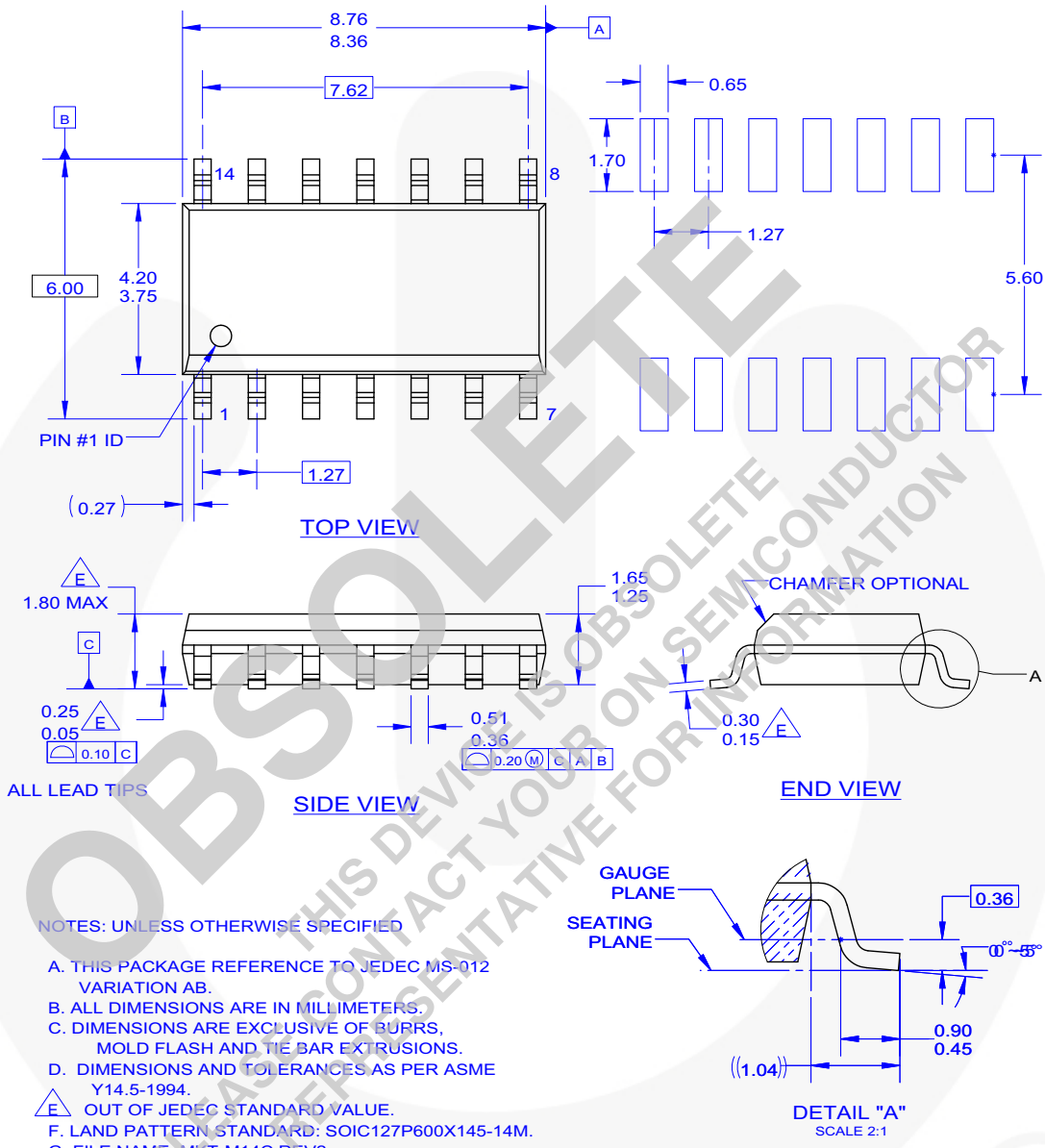


Figure 16. 14-Lead, SOIC, NON-JEDEC, .150 INCH NARROW BODY, 225SOP
