





DC CURRENT GAIN : hFE





Fig.4 DC Current Gain vs. Collector Current (II)




Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current (I) Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II)




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs. Emitter Current

Fig.9 Emitter Input Capacitance vs. Emitter-Base Voltage Collector Output Capacitance vs. Collector-Base Voltage




Fig.11 Safe Operating Area (II)




Fig.10 Safe Operating Area (I)





Fig.12 Safe Operating Area (III)




Fig.13 Safe Operating Area (IV)

Fig.15 Safe Operating Area (VI)





Fig.14 Safe Operating Area (V)








