




Typ. drain-source on-state resistance




Typ. gate charge characteristics







On-resistance vs temperature

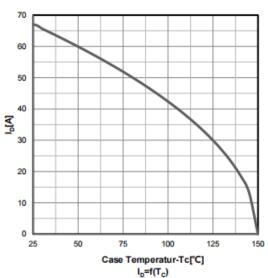
Forward characteristics of reverse diode



Drain-source breakdown voltage




Drain current vs temperature
